Stance on the Government GX policy	Consistent	➤ In order to contribute to Japan's ambitious policy of achieving carbon neutrality by 2050, the Japanese steel industry has declared that it will boldly take on the challenge of achieving it. ➤ The JISF has requested the establishment of a national strategy for decarbonization, financial support for practical application and implementation of the results of technology development, and fostering of public understanding about the huge cost of decarbonization, and building of a mechanism to bear the cost by society.	
Stance on energy policy	Consistent	➤ The JISF emphasized the need for concrete policies to promote decarbonization based on the premise of strengthening industrial competitiveness and stable, low-cost supply of energy, as the integration of energy policy and industrial policy is an extremely important viewpoint in promoting GX. ➤ The JISF has argued that it is very important from the viewpoint of energy security that Japan, which is poor in energy resources, has various options including renewable energy, nuclear power, and decarbonized thermal power. The JISF has thus advocated the need for decarbonized power sources including renewable energy.	
Stance on carbon pricing	Consistent	➤ In its opinion on the GX2040 Vision, the JISF appreciates that the "Growth-oriented Carbon Pricing Initiative" has clearly indicated the time of introduction and basic framework of the emission trading system (ETS), etc. ➤ In preparation for the full-scale introduction of the GX-ETS, the JISF is trying to provide appropriate opinions so that it will be designed as a scheme that will contribute to the promotion of GX in steelmaking processes and the strengthening of the international competitiveness of the Japanese steel industry.	
Stance on GX steel market formation	Consistent	➤The JISF appreciates that the GX2040 Vision has broadly described the GX market creation, which is essential for enhancing the predictability of decarbonization investment, mainly focusing on the the matters to be currently undertaken, such as visualization of GX value, public procurement, and private procurement. ➤As creation of the GX market is one of the important pillars, the JISF advocates that the government should clarify the direction and roadmap of specific measures such as "regulatory and institutional measures for procurement," in light of the importance of government efforts in matters including creation of initial demand for market creation and in order to increase the predictability of investment returns.

Keidanren has recommended the government to formulate a "GX Policy Package," which will be a grand design for GX.	
Stance on energy policy	Consistent	➤ Keidanren believes that whether Japan succeeds in preserving its industries and growing its economy depends on securing sufficient decarbonized power sources such as renewable energy and nuclear power. Keidanren thus argues that it is essential to secure renewable energy that meets the three requirements of low cost, stable supply, and business discipline as much as possible, and to make the most of nuclear power with a good balance of 3E (Energy security, Economic efficiency and Environment).	
Stance on carbon pricing	Consistent	➤ Keidanren emphasizes the importance of materializing the growth-oriented carbon pricing concept, and argues that the appropriate design and operation of the GX-ETS (Emissions Trading Scheme), which can both reduce GHG and strengthen industrial competitiveness, is necessary.	
Stance on GX steel market formation	Consistent	➤ Keidanren argues that the GX market creation is essential to increase the predictability of GX investments. ➤ Keidanren also argues that the increase in costs associated with the production of GX products should be reflected in the product price, and that consumers who purchase them should accept the increase in costs so that society as a whole can bear the costs fairly and equally.
